# CALL TO ORDER/PLEDGE OF ALLEGIANCE

> The October 17, 2017 meeting was called to order with the pledge to the flag.

#### **PUBLIC HEARING – 2019 BUDGET**

A motion was made by G. Vest, seconded by P. Keller to open the Public Hearing. All in favor.

## **Public Comment**

- ➤ Rob Hufcut commented on the Town's spending of and not receiving a grant promised by Senator Bonacic. He also commented on the increase in the highway budget.
- ➤ Janet Lybolt asked for clarification of the proposed Town Manager position and whether it would be a board appointed position. Supervisor Herrmann responded that the position would be a 5 year contract and out of the political influences. G. Vest added that the position would be given to someone stronger in budget type issues etc. as opposed to being done by a board that could change 100% every 2 years. J. Lybolt then asked if staggering the terms of office was still on the table. G. Vest responded that some research was being done.
- ➤ N. Salomone stated that initially he was in favor of a Town Manager but has since become skeptical as to the overhead involved.

- >W. Herrmann added that a benefit package would be included in the town manager position which would also include budget officer and that the position of Supervisor would then be part time.
- ➤ B. Giraldi added that year's ago there was no oversight of monies and that the town needs someone with experience, a degree, human resources, public relations etc.
- Chris Leser applauded the boards increase for the ambulance district and added that Sullivan County is looking into staggered terms.
- ➤ Roslyn Kalifowicz-Waletzky spoke about the proposed Town Manager position and the powers that they could have and referenced the State of Michigan's troubles with it.
- Councilman P. Keller stated he would like to see funding for our own school district. There is plenty of land adjacent to the Chase School to build a Middle and High School and would prevent the children from traveling 20 plus miles to school.

A motion was made to close the public hearing to oral comments but leave it open to written comments for 7 day by C. Saward and seconded by G. Vest. All in favor.

Real Property Division is developing GIS, the Geographic Information System, which will provide more accurate information for example on what poles are down on what roads during storms; in the past, information did not always match.

When a veteran goes to the hospital, it was stressed that spouses should not sign anything, and, before the veteran gets a room, establish the hospital will bill the VA within 30 days; doctors and ambulances too.
