Section 1. Legislative purpose. When the State statute which authorizes municipalities to offer a partial real property tax exemption to qualifying Cold War veterans was enacted, that statute, which took effect in January 2008, limited the exemption for a period of ten years. The State recently amended the statute to provide that a municipality, by local law, may extend the exemption without a time limitation. The purpose of this local law is to extend and continue the partial real property tax exemption for qualifying Cold War veterans.

Section 2. Section 175-3, titled "Exemption granted; purpose" of Chapter 175, titled "Tax Exemption for Cold War Veterans," of the Code of the Town of Mamakating is amended by adding a new subsection C to read as follows:

C. The partial real property tax exemption granted by this chapter shall apply to qualifying owners of qualifying real property for as long as they remain qualifying owners, without regard to the ten-year limitation contained in state Real Property Tax Law §458-b(2)(c)(iii).

Section 3. This local law shall take effect immediately upon filing with the Secretary of State.


