HIGHWAY SUPERINTENDENT'S REPORT

- We have been busy doing ditching, road repair from last fall's storm, pothole repairs, roadside mowing of brush and tree limbs. Road sweeping is also being done.
- Today we started Shawanga Lodge Road project that had been shut down since last December. If everything goes well with the weather that project should be done by April 22, 2021.
- Preventative maintenance on all our snow removal equipment is underway. This is a very timely and expensive process but it is extremely important.

- We are trying out treating all our trucks and snow equipment with a salt neutralizer to help prevent or slow down the rust and wear on the equipment.
- Next week Monday, April 12, 2021, Orange & Rockland is going to be doing extensive tree
 removal that I have asked them to do for us, also the Town of Wallkill will be doing the
 remainder of what O& R can't do for us.
- Our Capital Repair Project on Echo Road is still waiting for Frontier Communications to move their phone lines and remove the old poles. We have sent emails and they have a work order in to do the work but will not give us a date. Ben maybe could contact them as well to help move along this process.
- We started our (4) 10 hour work days. Our hours are 6 AM -4:30 PM, Monday –Thursday, until after Labor Day
- We will be requesting permission to place (1) snow plow and (2) old sanders for bid on Auctions International.

SUPERVISOR'S REPORT

- With the new Covid-19 Variants raising Covid-19 cases up in Sullivan County, I have extended Mamakating's Local State of Emergency through May 2nd.
- Reminder: The DEC Burn Ban is in effect March 16 through May 14th. We had a ridge fire in Westbrookville yesterday due to people burning, so, please, adhere to the Ban.
- Senator Schumer held a press briefing last week in Emma Chase Elementary school regarding the American Rescue Plan and the money that will be put into expanding and providing broadband throughout New York.
- A reminder that the K-Line Bridge Road over Rt 17 will be replaced. Full closure to begin this week through mid-July.


