Dear Summer Camp Parents/Guardians:

Are you ready for the Summer? Camp season is just around the corner! The Town of Mamakating is planning for a great camp season. The Town is lucky enough to have Leo & Barb, our Camp Directors, come back again this season to share their experience with your children. Leo and Barb have many years of experience running our summer camp and are very excited for the upcoming camp season this summer. There are many exciting traditions that will continue and some new programs and ideas that will make their debut this summer. This summer is sure to be exciting and memorable.

The Town of Mamakating Camp will be held at Mamakating Town Park in Bloomingburg. Camp is a 6 week program that will start on July 5th and run through August 12th 2022. Camp starts at 9am and ends at 3pm and a before and after camp is also available. Camp is open to all campers' ages 5-14 years of age. Campers ages 5 & 6 will be in a specialized age appropriate Pee-Wee Camp each day. Our campers are equipped with a fully operational swimming pool which will be incorporated into your camper's daily activities. Before and after camp is available from 7:00 am until camp starts at 9:00 am & after camp from 3:00 pm – 6:00 pm. Our summer campers spend the entire day outside! They will come inside only if the weather becomes dangerous with lightning storms. The children have their choice of several outdoor activities throughout the day. We recommend that no electronic devices are brought to camp! Children find it tough to live without their iPhones, iPods and other electronics for the first two days and, yes, they do complain for a while. But they are all in the same boat, so they talk to each other and complain to each other and grow closer and make friendships and that's good.

Registration is available in person at Town Hall or you can go on-line to www.mamakating.org following the link to summer camp 2022. Registration will begin starting April 18th and will run until all spots are full. You may print out the application on our website and mail it to the Town of Mamakating or drop it off at our Parks & Recreation Dept. Please note that the peewee program fills up quickly! All registration must include the following:

1. Completed & Signed Camp Registration Form
2. Copy of up to date immunization records
3. Proof of Residency for Resident Rate
4. Payment in Full (No partial payments, No Refunds)
5. Completed & Signed Permission Slips

CAMP DISCIPLINE POLICY:

Discipline is most effective when it deals directly with the problem at the time and place it occurs, and in a way that campers view as fair and impartial. Counselors and administrative staff are expected to use disciplinary action (in the form of time-out from activities) only when necessary. Disciplinary action should be firm, fair, and consistent so as to be the most effective in changing camper behavior. We will always consider the following: the camper’s age, nature of the incident, and the circumstances that led to it, camper’s prior disciplinary record, and the effectiveness of prior discipline (time-outs). As a general rule discipline will be progressive, meaning camper’s first infraction will merit a lighter penalty, (a shorter time-out) than subsequent infractions. Camp counselors are instructed to inform a Director if a camper exhibits violent behavior, bullying or a regular pattern of misbehavior. In such cases, Director will speak with the camper, if the misbehavior continues; the Director will notify parent/guardian to discuss possible options. In the case of extremely violent behavior, we reserve the right to dismiss a camper from the summer program without warning.

Our camp is not equipped to provide extra resources/care for children with special needs that would require a one on one. If your child receives any extra support while in school for behavioral needs or have trouble participating in large groups, you may have to carefully consider the fit here at the Town of Mamakating Summer Camp! Summer camp is supposed to be a fun experience but if children are not given the resources they need it can be a very stressful place for them and our staff as well as you the parents. Please also understand that if your child is dismissed or you later decide it is not the right fit, no refunds can be given. We hire our staff based on our number of campers.
